# 131. PUBLIC SESSION

131.1 Cllr White raised the consultation for organ donation currently live to change from the opting in system to an opting out system and asked that the Town Council supports the opting out system.

132.2 District Cllr Cooper raised the funding for the Leisure Centre and his concern that Parish Councils surrounding the town contribute very little to the Leisure Centre and all should be done to encourage these to contribute.

## 132. REPORT FROM COUNTY COUNCILLOR

- 132.1 <u>Lidl Bus Service</u> MoreBus have now 'officially' confirmed that they will be starting the Lidl bus service from the 2<sup>nd</sup> January in the form of a new X8A service. This will be a half-hourly Blandford town circular service. This service will flow in the opposite direction (anti-clockwise) to the X8 around Blandford. Although this service was agreed by the District Council through a S106 agreement, the task of organising this service with the bus company fell to DCC. Cllr Quayle thanked Cllr Lacey-Clarke for his support through the District Council.
- 132.2 <u>Blandford Bridge works</u> The culvert work, which was due to be completed in a few weeks, has now got a completion date of the 22<sup>nd</sup> December, due to a number of technical issues that arose during the course of the works. There will still be maintenance work carried out on the bridge in the New Year, but this should not include road closures or long-term traffic management.
- Blandford Leisure Centre Previously Cllr Quayle reported in confidence that his attempts to seek extra funding for the leisure centre were approved subject to confirming with the District Council and deciding on the terms etc. and officially confirmed that DDC would continue to support Blandford Leisure Centre with a further three years funding, despite originally minded continuing only until April 2019.
- 132.4 <u>S106 Slab Funding and Slab Works</u> Cllr Quayle thanked the Town Clerk and the Project Administrator for their continued support with regards to the retexturing work for the town's slabs. A quote has been received from one provider and are due to meet with another in the coming week. NDDC has confirmed that appraisals of all the projects for S106 funding has almost been completed, and a decision should be issued in January. SSE are due to be issued with another fine as they have still not replaced the pavement to standard.

# 132. REPORT FROM COUNTY COUNCILLOR (CONT)

- 132.5 <u>Parking Review</u> Cllr Quayle thanked the Assistant Town Clerk for her continued work in supporting the Parking Review. A meeting has been held with Blandford Camp and their concerns around Black Lane has been recorded. Cllr Quayle reminded Councillors to try to encourage as many of their residents to complete the survey or email the Town Council via the website.
- 132.6 <u>A350/C13 consultation</u> DCC Cabinet voted to adopt Option 1, One Way Advisory HGV Routing (Current) Northbound on A350 Southbound on C13/B3081.
- 132.7 <u>Tinpot Lane Feasibility study</u> This has now been completed and funding is trying to be identified for the link road.
- 132.8 <u>Joint Committee work stream</u> Cllr Quayle has been assigned to the Task and Finish Group on Community Partners Engagement (Parish and Town Councils) (DAPTC).
- 132.9 New Waste Plan Consultation Cllr Quayle asked Councillors to respond to this consultation, due to end 31st January 2018.
- 132.10 <u>Cycle consultation</u> Cllr Quayle asked Councillors to respond to this consultation, due to end 31<sup>st</sup> January 2018.

Cllr Lacey-Clarke asked for clarification on the Leisure Centre funding. Cllr Quayle explained that DCC are looking at withdrawing funding from services such as leisure centers and therefore he pushed for three years.

Cllr Lacey-Clarke asked when there will be an opportunity to hear proposals from the Living and Learning Team. Cllr Quayle explained that they are still finalising their plan for Blandford and have been offered dates in the new year. Nothing has been confirmed as yet and they are coming to consult on what the proposals could be.

## 133. REPORT FROM DISTRICT COUNCILLORS

- 133.1 <u>Cllr Jackie Stayt</u> Cllr Stayt reported that the Planning meeting scheduled for January has been cancelled as there was not enough to go on the agenda. There is a site visit in January in Stalbridge which will then be considered at the February meeting.
- 133.2 <u>Cllr John Tanner</u> At the last meeting Cllr Tanner represented 20 Hinton Close and visited the site yesterday afternoon and nothing has happened. He also attended a meeting at the cricket pavilion and it may have to be positioned at the bottom of the field due to tree locations. Cllr Tanner has asked for a roadshow about what is happening to NDDC, but no feedback has been received yet. The meeting regarding S106 funds will take place in the first week of January.

- 133.4 <u>Cllr Lacey-Clarke</u> Cllr Lacey-Clarke attended a meeting with the Dorset for You website builders. The first few pages would be going live in February. It is only the main structure being done, the individual sections of the website would not be and would have to be done by individual departments. Cllr Lacey-Clarke is trying to influence the team so that one system is used across all departments.

#### 137. TOWN CLERK'S REPORT & CORRESPONDENCE

- 137.1 M4 to the Port of Poole Simon Hoare MP has written to the Town Council to inform Councillors of a letter he has sent to the Secretary of State for Transport regarding the strategic importance of the A350.
- Corn Exchange Project In response to John Turnbull's comments at the last Town Council meeting I confirmed that Heritage England does not require a conservation accredited architect. He had stressed that his concerns were with Heritage Lottery Funding and the Development Manager has confirmed: We do not require the use of a Conservation Accredited architect although that is often best practice. We do expect that appointments of the professional team are of high standard and relevant to the scheme at hand. We will also want to see appropriate sector-based consultation on the conservation scheme conservation officer, Historic England etc. We need to know that the relevant consents and permissions are likely to be achieved by the scheme at hand. What is important for us, however, is that appropriate tendering and procurement is followed. You can work with a pre-chosen architect up to Round 1 but if HLF funds are successful we will want to see that open procurement is followed.
- 137.3 ANPR The order has now been placed, our website has been updated and the works will take place in the New Year.
- 137.4 <u>NALC Conference</u> Cllr White, the Town Clerk and Assistant Town Clerk attended the annual conference on Wednesday 13<sup>th</sup> December in London and attended workshops on fundraising, local economic development working with the private sector, neighbourhood planning and health and well-being.
