#### 41. **PUBLIC SESSION**

Cllr Lacey-Clarke reported that the works to the paving slabs commenced on Monday 6th 41.1 September. Cllr S Hitchings posed a question to Cllr Lacey-Clarke before the meeting about the timings and duration of the one-way system in place. Cllr Lacey-Clarke reported that it will be in place for the duration of the works. Cllr Lacey-Clarke gave further details about the closure, communication with business owners and the need for a storage area.

#### 41.2 Western Design Architects – Tin Pot Lane

Jonathan Turvey shared a presentation outlining the new proposals and clarified that the applicant is predominantly looking to develop the upper site with this new application. The proposals are for six new single storey dwellings on the current stud farm. These bungalows will have less visual impact on the AONB and will be built to Passive House standards. The development will also be less dense than previously proposed. Mr Turvey spoke about the sustainability of the site with attenuation ponds and the possibility of using ground source heat pumps. The applicant is looking at using local materials to reduce carbon footprint of the scheme.

Mr Turvey then spoke about the lower site. The applicant, in memory of his wife, would like to develop this into a memorial site with 61 trees and a pond, for school children to use. He is already in contact with the Dorset Environmental Trust. The proposal also includes 12 off road parking spaces.

Jonathan Turvey has requested feedback from Town Councillors; therefore it was agreed that this will be added to the Planning agenda on 4th October 2021.

48.1 <u>The Hive, Kings Road</u> – A letter was sent as requested at the last Planning Committee meeting. An enforcement case was already open and BFTC's comments have been added.

#### 48. CLERK'S REPORT AND CORRESPONDENCE (cont.)

- 48.2 <u>Church Lane pedestrian crossing safety improvements</u> The Dorset Council plans to make safety improvements to the pedestrian crossing at the southern end of Church Lane. This is part of the works on the footways in Blandford Forum that are being carried out from the 6<sup>th</sup> September 2021 to the 22<sup>nd</sup> of November 2021.
  - The footway will be built out by just over a metre east on the western side to allow for greater visibility. The footway on the eastern side next to St Peter and St Paul's Church will be narrowed to accommodate for this.
  - Construction is programmed to start on Monday the 13<sup>th</sup> of September 2021, lasting 2 weeks until Friday the 24<sup>th</sup> of September 2021. It is planned to close the lower 40 metres of Church Lane for the first 5 days of the works only (13<sup>th</sup>-17<sup>th</sup> September), for the kerbs to be moved and replaced, as well as the new carriageway surface to go down.
- 48.3 Road Closure All vehicles will be prohibited from proceeding along Church Lane, Blandford Forum from Market Place to a point 40 metres to the north. The Notice is needed in order to comply with health and safety regulations which require the provision of safe working areas and to minimise the likelihood of danger to highway users. It will come into operation on 13<sup>th</sup> September 2021 between and remain in force for five days, but it is anticipated that the works will be completed by 17<sup>th</sup> September 2021. This Notice will enable Dorset Council to build out the footway on western side and take back the kerb line on the eastern side to maintain road width.
- 48.4 Road Closure All vehicles will be prohibited from proceeding along Alfred Street, Blandford Forum between Edward Street and Queens Road (in both directions), a distance of approximately 60 metres. The Notice is needed in order to comply with health and safety regulations which require the provision of safe working areas and to minimise likelihood of danger to highway users. It will come into operation between 08:00 until 18:00 on 13<sup>th</sup> September 2021 and remain in force for five days, however it is anticipated that the works will be completed by 17<sup>th</sup> September 2021. This Notice will enable B W Construction & Groundworks Itd safe access to connect a property to the sewer network. The alternative vehicular route will be sign posted via Edward Street, Alexandra Street, Albert Street and vice versa.

Cllr Lindsay returned to the meeting at 08.07pm.

48.5 <u>War Memorial Rededication</u> - Officers have sought a quote for the war memorial at the Cemetery to be cleaned and the lettering repainted, in addition they have also sought a price for a new inscription which reads: "A rededication service was held in 2021 to mark the centenary of the cross and tablets, and to remember all men and women of Blandford Forum fallen in service to their country 100 years on."

It is hoped that the work will be completed before the rededication service on 7<sup>th</sup> November but as the work can only be done in dry weather this cannot be guaranteed but it would provide a visual record of the re dedication. The total cost would be £3,407.20 including VAT. If approved, unofficially, tonight then a report would be taken to the Town Council meeting on 27<sup>th</sup> September seeking retrospective expenditure approval. It is suggested we use General Reserves for the cost. An e mail has been sent to all Councillors earlier today with the quote in detail.

A straw poll was taken with 13 in favour and 1 against. The item will be added to the Town Council agenda on 27<sup>th</sup> September to seek retrospective approval.
