Distance Selling Premises Application

Application by *P* & *D* Cards Ltd to open an internet pharmacy at 25 Salisbury Street, Blandford Forum, Dorset, DT11 7AU

Explanatory notes by NHS England

Q1. What is this application for?

P & D Cards Ltd wishes to open an NHS internet pharmacy at *25 Salisbury Street, Blandford Forum, Dorset, DT11 7AU*. This type of pharmacy is also referred to as 'distance selling premises' and operates under strict rules which means it is not able to provide services face to face at the premises.

A pharmacy can only give patients medicines prescribed by NHS GPs if it has NHS England's permission. We give permission for this type of pharmacy where we are satisfied that they will be able to provide services safely and effectively without seeing the patient face to face. This type of pharmacy provides the same services as any other type of pharmacy but you can't, for example, take your prescription there to be dispensed or collect it once it has been dispensed. Instead you could post it to the pharmacy or ask your GP to send it electronically. The pharmacy would then dispense it and send it to you either via the post or a courier.

These notes explain the process we follow when deciding whether to give permission.

Q2. Why have I been sent a copy of the application?

You are being invited to make comments on the application before NHS England takes a decision on whether the pharmacy can go ahead. Any comments must be received before the end of the 45-day period mentioned in the letter.

Applications are not confidential. If you want, you may share details with anyone else who might be interested. They can also make comments within the same 45-day period.

Any comments we receive will be sent to P & D Cards Ltd. They will have a chance to respond to us about those comments.

When we come to make a decision, NHS England will consider any comments it has received and any response to those comments from P & D Cards Ltd.

Q3. What would the pharmacy's opening hours be and what services would it provide? Section 3 of the application form includes the proposed opening hours.

"Core opening hours" are those which the pharmacy would be unable to change without our permission.

The pharmacy may also open for longer. This is called having "supplementary opening hours". The pharmacy would be able to change these by giving us three months' notice.

Every pharmacy must dispense NHS prescriptions, accept unwanted medicines for disposal and give advice on how to treat minor illnesses yourself.

Pharmacies may also offer other services. Most pharmacies offer:Medicines Use Reviews (MURs), which are sometimes called medicines check-ups

- the New Medicines Service (NMS), which is advice when someone starts a new drug
- vaccinations against flu.

The services that *P* & *D* Cards Ltd is offering to provide are listed in section 4 of the application form.

Q4. How will NHS England decide whether to give permission for a new pharmacy?

Firstly we need to check to make sure P & D Cards Ltd is offering to provide services to anyone in England who may want to use them.

Then we look at how they say they will provide services without seeing the patient face to face. We need to check to make sure they are able to provide all the services you would expect from a pharmacy safely and effectively.

Q5. When will a decision be made?

We expect to make a decision by 28 November 2020.

Q6. What will happen if permission is given?

If we decide to give permission for the pharmacy to open, this does not automatically mean that it will happen. Other local pharmacies may be able to appeal against the decision. Appeals are dealt with at national level by NHS Resolution. If no appeals are received or if they are rejected by NHS Resolution, P & D Cards Ltd would then have up to six months to open, although this could be extended to nine months. If those deadlines were not met, then the permission would expire.

Q7. What if permission is refused?

P & *D* Cards Ltd would be able to appeal.

Clerk's Report & Correspondence

- 1. <u>Grant Funding</u> Blandford + has received an additional grant from Locality of £714. This will cover the Blandford + website cost for one year and printing of leaflets to promote the plan before the referendum.
- 2. <u>BCP Local Plan</u> The representations received on the BCP Local Plan Issues Consultation and the Call for Sites have been published on the BCP Planning web pages.
- 3. <u>Road Works</u> From 5th September a temporary traffic management order will be in place on A350 Bournemouth Road, Charlton Marshall to enable the Dorset Council to carry out carriageway maintenance and resurfacing works. it is anticipated that the works will be completed by 11th September 2020. The effect of this order is to impose a temporary 10mph speed limit to facilitate convoy working upon Bournemouth Road, Charlton Marshall from Badger Roundabout to a point 200 metres to the south of the junction with Meadow Road, an overall distance of approximately 2670 metres. Clearways, indicated by signs on site, will be imposed on each road to prevent waiting or parking on the highway or verge in these locations.
- 4. <u>VE/VJ Day Bench</u> This bench has now been installed in the Tabernacle. Expenditure authority was approved at the Town Council meeting on 24th February for up to £1,200. However, the production of the bench has come in at £1,620. The difference in cost will still be charged to the same budget line, new benches. The Phoenix bench previously installed at the Tabernacle has been moved to the Town Pump.
- 5. <u>Assets of Community Value</u> The Town Council's nomination for the Methodist Church is still outstanding as there is an issue with the ownership of the car park, which the The Dorset Council solicitors are looking into.
