#### 22. **PUBLIC SESSION**

#### 26. TOWN CLERK'S REPORT AND CORRESPONDENCE

- Dog related Public Spaces Protection Order for Dorset Council The new order will come 26.1 into force on 1st January 2021 and will be valid for three years. Dorset Council have requested for the new order to be publicised, which we will do in all our notice boards. For clarity the Order is in parts
  - Clearance of fouling
  - Exclusion from certain identified areas
  - Dogs on leads in certain identified areas whether generically identified or by name
  - And dogs on leads as directed by an authorised officer.

# 26. TOWN CLERK'S REPORT AND CORRESPONDENCE (CONT.)

Currently the Dorset Council's Dog Warden Service undertakes dog related and animal welfare licensing work across Dorset. They currently have 4.5 FTE Officers. Whilst they will endeavour to undertake patrols in known hot spot locations – data of which can only be accumulated over time, the physical effect of the number of officers means they cannot be at every location all of the time. With this in mind Parish and Town Councils could employ suitably qualified and competent officers to be authorised by Dorset Council to serve Fixed Penalty Notices. The Dorset Council have the intention in the coming year to schedule a one day course by a DEFRA qualified trainer in this area of work, and would appreciate an indication of interest and possible officer numbers that could take the course. There are a number of Parish and Town Councils that employ officers for this task either as a part time enforcement officer or as apart of other duties.

The Town Council has ordered new signs from the Dorset Council, to display in all play areas, the skate park, Woodhouse Gardens, Park Road and Larksmead Recreation Ground, Langton Kick About Area and the churchyard.

26.2 <u>Calendars</u> – The calendars for 2021, raising funds for the Mayor's Charity – The Community Kitchen, have now sold out. The Chairman congratulated the Assistant Town Clerk for all her hard work with this.

Nic Nicol reported that the Town Team website is now sponsored by the Blandford Business Support Group, with a small grant being received to cover advertising. The group have changed their Public Liability Insurer to cover for public activities. The group is pleased to be closely involved with the Town Centre Enhancement Working Group. The next meeting is on 26<sup>th</sup> November.

#### 27.5 Parking Review Working Group

Cllr Quayle confirmed that the parking review is completed, and recommendations have been presented to both the Dorset Council and the Town Council. Further recommendations have now been made by other groups and these need to be tied up with the parking review. There will not be an update until there is a steer from the Town Centre Enhancement Group on how they want to move forward. The position might be contradictory to the recommendations from the parking review. However, there needs to be a joined up view from the Parking Review Group and the Town Centre Enhancement Group so this can be taken forward, which Cllr Quayle is ready to do.

Cllr L Hitchings enquired if the Town Council can vote on the recommendations from the parking review. Cllr Quayle responded saying that there was a vote, and the vote went ahead to take the recommendations forward. It was confirmed that there was no vote from the Town Council, and that the vote was only taken by the Steering Group.
