115. PUBLIC SESSION

115.1 <u>Treads</u> – Libby Lloyd spoke on behalf of Treads and updated Councillors on their recent activities, which include a cooking session with Ukrainian families and offering paid opportunities to young people who used to use Treads. There is another initiative called Art to Heart, which is a great way of allowing the children to get creative and express themselves. Libby advised Councillors that there are a lot of younger children struggling with anxiety and Treads is coming up with ways of supporting them. In the New Year, they are going to go back into the school to present an antibullying workshop. Cllr Chapman asked how they are coping with the costs for the art project and Libby explained they had obtained funding to support it. They also received a few donations of painting materials and fabrics and if anyone would like to make a donation, they can take it to the new location for Treads at the Blandford Scout Hut. Cllr Carter thanked Libby for everything she does for the children and asked if she has regular meetings with the school. Treads tends to get 15-20 children per session and are considering changing the constitution to enable them to lower their age range.

116. REPORT FROM DORSET COUNCIL COUNCILLORS

Cllr Lacey-Clarke gave the report this month.

Cllr Lacey-Clarke mentioned that the latest round of the Dorset Council Community and Culture Project Fund is now open and applicants must raise at least 20% of the costs themselves. The deadline is in January and applicants must meet at least one of the Dorset Council priorities.

The winter coats initiative is returning this year and members of the public can go to Blandford Children's Centre between 9:30am and 4pm to collect a warm coat for a child.

Cllr Lacey-Clarke encouraged people to report matters online on the Dorset Council website and noted that a lot of people have been doing this recently. For example, highways matters can be reported quickly and easily online.

The Town Clerk explained that we would be able to photograph all the town silver and catalogue or display it so items can be safely stored but shown on a screen in the venue. This was supported by the Chairman of Council and the Museum is now awaiting a response from the Fashion Museum and the Parish Church.
