

All in attendance should be aware that filming, recording, photography or otherwise may occur during the meeting.



To consider expenditure approval for new insurance for the Town Hall / Corn Exchange

Report

Due to the extent of the Town Hall / Corn Exchange renovations and the building's Grade I Listed status, the Town Council's existing insurance company has advised that the council requires extra insurance to cover the building for the duration of the works, in addition to the "existing structure" cover.

A quote for "works in progress" insurance was sought from the council's existing insurance company in February 2024 outlining the value and length of the works planned. They responded with several questions which were sent to the preferred contractor for answers. This whole process took a long time to complete, and it was a surprise when our existing insurer declined to quote for the extra insurance and asked for the following to continue with our "existing structure" cover whilst the works took place:

- Additional Premium of £15,911.60 (including IPT).
- £5,000 Excess.
- Wet Perils excluded during anytime that the existing structure is not watertight.
- Security Features: Out of hours security would have to be adequate, i.e. not just hoarding and Heras fencing, but remote signalling intruder alarm system with Level 1 police response or remotely monitored CCTV.
- Full Compliance with Unoccupancy Conditions (Page of Policy Wording).

This outcome was not expected by our customer advisor, but he did reassure us that cover remained active as long as we don't do anything structural in the meantime. This was communicated to our contractor who has planned round this until we have full cover, to avoid delays.

The RFO at Dorchester Town Council was asked for his experience because they too have undergone major works to their Town Hall and Corn Exchange. An additional insurance broker specialising in Parish and Town councils was approached, based on their recommendation. Apparently, it is quite common to have the Existing Structure insured by one company and the Works covered by a different firm.

Although not expecting the cover to be quite this high there was an expectation of a large increase in the premiums due to the size and amount of structural works on a Grade 1 listed building.

Officers have sought alternative quotes for cover and received the following:

Financial implications

- Company A Existing Structure Insurance £15,911.60 Incl. Insurance Premium Tax (IPT). Works Insurance Not prepared to insure.
- Company B Existing Structure Not prepared to quote as they cannot match or compete with the quote from Company A Joint Cover Works insurance £9,309.40 Incl. IPT, for duration of the works.
- Company C Existing Structure £quote awaited

 Joint Cover works insurance £quote awaited

We have heard from our Contractors who are working on the Corn Exchange and their price for upgrading the security to the monitored CCTV and responding the Fire Alarm Would be: £ 10,237.50 This is to comply with the requirement from our existing insurer to continue the "Existing Structure Insurance".

Recommendation

It is recommended that the council approves expenditure to obtain insurance cover for the Corn Exchange Complex once all quotes have been received. It is also recommended that an extra £10,237.50 approved to upgrade the security.
