9. **PUBLIC SESSION**

Tristan Day was in attendance from Offcamber Cycles as he and his Dad, Julian Day suggested the introduction of a pump track in Blandford. It is a simple looping course for bikers, scooters and skateboards. Instead of pedalling you pump to generate speed. It would be a space where everyone can join in, and it lets you join in at your own pace. A pump track doesn't replace the skate park, it complements it. The nearest one is currently a 30-minute drive away. They are relatively low cost to build and low maintenance.

14. TOWN CLERK'S REPORT & CORRESPONDENCE

14.1 Commonwealth War Graves Commission Tours – The Town Clerk and Business Support Officer met with Stew Kilby, volunteer for the Commonwealth War Graves Commission (CWGC) and Lt Col (Retd.) Bob Brannigan. The Commonwealth War Graves Foundation engages and educates people about the CWGC and part of that is offering free talks and tours of its war graves sections and Cllr Terry Clarkson thought it would be good to have these in Blandford Cemetery, where there are many CWGC war graves. Stew Kilby kindly offered free tours to be held in May, during the War Graves Tours week, and the aim is for people to find out more about the CWGC work involved in caring for cemeteries, memorials, and the history of the individuals commemorated. He has also offered to deliver a talk on the work of the CWGC in the Corn Exchange next year, which we welcome and look forward to. In addition, the Unknown Sailor headstone was discussed and lots of information has since been found, and it is hoped that a name will be confirmed and a new headstone introduced by the CWGC in due course.

However, due to the overall value for one contract the entire works – surfacing and equipment – will be advertised via Contracts Finder, specifying the method preferred by the Committee, and brought back to council in due course.
