13. MINUTES OF THE MEETING HELD ON 14th JULY 2025

It was PROPOSED by Cllr G Del-Pinto , SECONDED by Cllr S Morgan and AGREED (3 in favour, 4 abstentions) that the Minutes be APPROVED and SIGNED.

14. **COMMITTEE CLERK'S REPORT**

The paper was noted (see Appendix A).

Dog Waste Bin request, Angus Close - At the last meeting the committee heard a request from a resident in Agus Close for a dog waste bin to be installed due to the high volume of waste being left on the floor. The committee agreed to contact the housing provider, Sovereign, who owns the land to see if they would carry this out. They responded on 20th August to say that regrettably, they have advised that they would not install this, as they have no infrastructure set up for collections. They have said they will speak with residents and ask those who are dog owners to be more mindful when it comes to disposing of dog waste.

Previous request for traffic calming measures on Park Road – A resident's request for a speed survey on Park Road was heard at the last meeting. The council responded informing them they agree speed can be an issue on this road and would support the idea of a group of residents carrying out a speed survey. The resident declined the idea of volunteering to carry out a speed survey. The relevant team at Dorset Council advised that a survey was carried out in 2018; the results then showed speeds to be low and as the layout of the road hasn't changed since this survey it is unlikely to be much different now.

15. GENERAL UPDATES FROM:

- 15.2 <u>Blandford Police</u> A report was circulated to Councillors prior to the meeting. Councillors were thankful for the report. Cllr Lacey-Clarke has noticed and welcomed an increased police presence around town, with police engaging with residents, as well as issuing fines to those parking on hazard lines.
- 15.3 Market Manager The paper was noted (see Appendix B). Councillors hope that, once the corn exchange is open, the number and quality of pitches increase. Cllr G Del-Pinto asked if the trial of pedestrianisation in the Market Place could have an effect on the market holders. Cllr L Hitchings suggested that it should not have any detrimental effect as the market stalls will be placed within the pedestrianised area. The Market Manager will be discussing this with market traders in due course.

16. <u>DORSET COUNCIL HIGHWAYS</u>

16.1 <u>To discuss a resident's concerns over pedestrian crossing points on Salisbury Road</u>

It was PROPOSED by Cllr Clarkson, SECONDED by Cllr H Miéville and AGREED unanimously that

There is currently a safe walking route that uses two crossing points, both of which have access to the schools and therefore the council cannot support this at this time, however the council will contact Dorset Council to ask them to maintain the pedestrian crossing by the cemetery which is often out of use.

The council suggests that in future years we could look at members of the public to come forward to volunteer to take part as a judge.

Councillors suggested the council obtain quotes to investigate the cost of refurbishing the Marsh and Ham public toilets before we suggest any other items for inclusion in the 2025/26 budget.
