Prior to the start of the meeting, Michelle Spruce signed the Declaration of Acceptance of Office. Cllr Spruce received an absolute majority at the co-option meeting held prior to this full council meeting and is now a Town Councillor representing the Langton St Leonards ward in Blandford Forum.

#### 94. **PUBLIC SESSION**

Cllr Stevens raised concern over the closure of the launderette and the lack of washing machines in the town. Cllr Lacey-Clarke said there is a business at the top of town where people can take their washing. However, Cllr Quayle added that it is an expensive facility.

#### 95. REPORT FROM DORSET COUNCIL COUNCILLORS

Cllr Quayle asked that Councillors encourage local groups to apply for the funding streams via the Dorset Council.

After 18 months of no appointment, the area now has a Community Highways Officer starting on 1st December 2025. He asked that Councillors inform him of any issues that he and Cllr Lacey-Clarke can raise with the new post holder.

The Dorset Council is currently working on the budget for the 2026/27 financial year and is publicising an opportunity for residents to try to balance the budget.

Cllr Quayle referred to a report by the Dorset Council about passing services on to town and parish councils. As part of this process, area boards are being introduced.

The Dorset Council Highways Team has started to grit roads in the recent cold weather.

Cllrs Stevens and S Hitchings declared an interest in the Blandford Opportunity Group grant application and stated they would leave the room during debate, discussion and voting.

### 98. MINUTES OF THE TOWN COUNCIL MEETING HELD ON 27<sup>TH</sup> OCTOBER 2025

It was PROPOSED by Cllr Cross, SECONDED by Cllr Chapman and AGREED (12 in favour, 3 abstentions/non-votes) that the Minutes be APPROVED and SIGNED.

### 99. TOWN CLERK'S REPORT & CORRESPONDENCE

The paper was noted (see Appendix A).

Town Hall Mantelpiece Clock – The horologist was asked to suggest a suitable clock for the Town Hall mantelpiece and he proposed an antique French Brocot Slate & Marble Barrel Clock S. Marti. It is a late 19th century French mantel clock in Belgian slate and variegated marble with gilt inlays to the case front. The clock has a brass surround to the white enamel dial with Roman numerals, a visible Brocot escapement and blue steel hands. With an 8-day S.Marti movement striking a pleasant bell on the 1/2 hour and hour. The Town Council purchased this clock via eBay at a cost of £125 in October 2025, and the seller was happy to provide information about its history as it was purchased when it was already fifty years old at a house sale in Dorset in 1935 by the seller's grandfather Eric Jackson who at that time was running his butcher's business in Milborne Port. The history has been recorded on the Town Council system, but will also remain with the clock in case anyone wants to learn about it.

<u>Picture Hanging</u> – SK Picture Framing recommended a picture hanger for the Town Council to use and he has put up the picture of HM The King in the lobby, along with the Blandford Races, all the council photos we had in the Council Chamber, along with the Freedom pictures and he will also secure the Town Hall pictures the grounds team put up last month.

Opening Event – All the funders have been invited to attend the Opening Event on Sunday 30th November 2025 and one invite has turned into the funder hosting a meeting in the building, with the Town Clerk also provided a tour of the complex. Geordie Thomson has offered to play the Blandford Forum fanfare at 12:30pm when the Mayor and Sam James will be on stage and Simon Hoare MP has kindly agreed to attend. At present the event is costing £3,000 of the approved £5,000 budget.

<u>Police Presence</u> – The Police came into the office last week to say that we can expect to see an increased Police presence over the coming weeks/months in the town and they will be out patrolling the town during Yuletide Festival. They spent the summer months being called out to Bournemouth and Weymouth a lot but now the tourism season is over we should expect to see them more. The Committee Clerk informed him that the B+ group mentioned in a recent meeting that an increased police presence had been noticed in the town recently.

<u>Events / Mayor's Assistant</u> – The Town Clerk confirmed that Zoë Bridgeman has been appointed as Events / Mayor's Assistant.

The Town Council delegates authority to the Town Clerk and Operations Manager to create a policy and bring it back to Council for consideration.
