The Chairman welcomed everyone to the meeting and read the housekeeping notice for the members of public in attendance. He mentioned the sad loss of Cllr Lacey-Clarke's mother. He also referred to the successful Opening Event in the Corn Exchange on Sunday 30th November 2025 and the Carol Service in the Parish Church on 3rd December, both of which attracted positive feedback, and congratulated the volunteers who put together the Blandford Yuletide Festival event.

111. PUBLIC SESSION

Cllr Cross provided a company to get in touch with about the potential pump track project.

- 111.1 Daniel Cadisch Chief Officer, Citizens Advice Central Dorset Daniel updated Councillors on the financial position of the organisation and the biggest challenges they, and their users, are facing. There has been a shift in the last year, with more people in personal debt. He thanked the Town Council for its financial support and for hosting the CA on a Friday morning within the council offices. In addition to the office support, they also offer digital support. Councillors asked questions and the Chairman thanked Daniel for the valuable work the CA carries out and for all his efforts.
- 111.2 The Blandford School, Alan Jones and Chair of Governors, Jens Bertelsen Jens explained he succeeded James Vaughn as the Chair of Governors and his first task was to lead a panel of governors to select a new Headteacher. Alan Jones was the successful candidate after spending over two decades in London. He took the opportunity to introduce himself and explain his background and aims.

112. REPORT FROM DORSET COUNCIL COUNCILLORS

Cllr Quayle asked that Councillors direct any issues to him at this time and reported on the devolution deals currently being discussed at Dorset Council. His understanding is that the DC administration is keen on pursuing the new Mayoral-led authority, which is being looked at for 2027. A family hub is due to be shared between Blandford and Sturminster Newton in 2026, with one location here and one in Sturminster Newton. Some areas have been flooded recently due to the extreme weather and Dorset Council is looking into these problem areas. Due to recent reports, he asked Councillors to let him know if there are any issues with litter bins.

- 116.1 Woodhouse Gardens Lights The contractor installed the lighting scheme prior to 1st December and the gardens will be lit between 4:30pm and 9pm every day during the festive season apart from Christmas Day, Boxing Day and New Year's Day.
- 116.2 <u>Mayor's Christmas Card</u> The card has been chosen by the Mayor, Cllr H Miéville and has been printed locally.
- 116.3 Christmas Tree Staff have received very positive comments about the Christmas tree.
- 116.4 <u>Civic Carol Service</u> The office has received very positive feedback for the civic carol service held on 3rd December 2025.
- 116.5 <u>Lamperd's Field</u> The Town Council's solicitor has confirmed that the Town Council has exchanged and entered into the surrender and replacement allotment agreements relating to Lamperd's Field.
- 116.6 The Friends of Blandford Community Hospital Thanks to the Friends, the ticket price of the Frankie's Guys event has been reduced by £10 per person and they have offered to support two other tribute acts. In addition, three daytime discos have been booked for the first Tuesday of February, March and April with the aim of promoting socialising, mental health and activity and they are covering the cost of the DJ and will run the kitchen. The ticket sales will go to the council to cover the cost of the room hire/staffing.
- 116.7 <u>Corn Exchange Tours / Talks</u> The Town Clerk hosted Clerks in the county and gave a talk on the project on Tuesday 9th December as part of the Society of Local Council Clerks meeting and, along with the architect, delivered a presentation to Conservation Officers on 11th December 2025.

The Town Clerk updated Councillors at the meeting on ticket sales for forthcoming events, and informed Councillors that the Charity of William Williams is holding a meeting on site on Tuesday 6th January 2026 after a tour of the venue and brief overview of the project.
